ENTRY REQUIREMENTS

Any foreigner looking to enter DRC will be required to have the following documents:

- A valid national or international passport or other valid travel document with at least 1 blank page
- A valid travel visa, Kenyans are also eligible for visa on arrival
- Yellow fever certificate
- Currency restrictions for entry 5 Million CDF (\$5,400)
- Currency restrictions for exit It is illegal to export CDF

In addition to the above, the entry, exit, residence and movement of foreigners is determined by the following legal regulations:

- 1. Ordinance Law No. 83-33 of 12th September 1983 relating to the police force for foreigners as amended and supplemented to date
- 2. Ordinance Law No. 87- 281 of 13th August 1987, implementing Ordinance No. 83-33 of 12th September on the police for foreigners, as amended and supplemented to date
- 3. Act No. 86-007 of September1986 regulating the residence and movement of foreigners in mining areas

TYPES OF VISAS

Entry into DRC requires administrative formalities depending on the nationality of the travellers and on the type of stay. In accordance with laws and regulations, the Directeur Général de Migration (DGM) is authorized to issue visas to foreigners wishing to visit DRC and to settle there. A visa may be granted only to applicants who fulfill the conditions laid down by laws and regulations.

WEATHER IN DRC

The DRC has a largely equatorial climate; however, this varies across the country's extensive land area. Generally:

- The country is hot and humid in the north and west, an area located within a significant portion of the Congo River Basin.
- The southern, central and eastern areas are generally cooler and drier.
- The DRC is home to an exceptionally high degree of ecosystems and habitats, notably dry rainforests (Muhulu), open woodland forests (Miombo), savannahs, as well as cloud and gallery forests.

Best time to visit DRC

Best visited either at the beginning or, better still, in the middle of the year, DRC has:

- a) a short dry season (January / February)
- b) a short wet season (March April)
- c) a long dry season (May to September) and
- d) a long wet season (October to December)

*Please ensure to carry both light and heavy clothes but anticipate frequent rain fall during your stay in the DRC



DRC'S RELIGIOUS AND CULTURAL DEMOGRAPHY

DRC has a huge Christian population (put at 80%) with a majority being predominantly Roman Catholic. Approximately 50% of the DRC's population is Roman Catholic, 20% is Protestant, 10% is Kimbanguist, 10% is Muslim while the remaining 10% comprises other religious organisations.

Local Languages Spoken in the DRC

The Democratic Republic of Congo is one of the most linguistically diverse countries in the world, with over 200 languages spoken in the country.

While French is the official language and widely used in education and government, there are four national languages: **Kikongo (Kituba)**, **Lingala**, **Swahili**, and **Tshiluba**.

Francophone African Sign Language and American Sign Language are both used in communication as well.

Kikongo ya leta (also called "Kikongo") is spoken in Kongo Central, in Kwango and in Kwilu provinces, and was promoted by the Belgian colonial administration.

Lingala, spoken in the capital Kinshasa, is increasingly understood throughout the country, as the lingua franca of trade, spoken along the vast Congo river and its many tributaries. Lingala's status as the language of the national army, as well as its use in the lyrics of popular Congolese music, has encouraged its adoption, and it is now the most prominent language in the country.

Tshiluba (also known as Chiluba and Luba-Kasai) is spoken in the south eastern Kasai regions.

Swahili is the lingua franca of Africa's Great Lakes region as well as east and southeast Africa. There are multiple dialects of Swahili that are spoken in the Congo. The most common is Kingwana, also known as Copper belt Swahili.



CUISINE

The cuisine of the Democratic Republic of the Congo varies widely, representing the food of indigenous people. Cassava, fufu, rice, plantain and potatoes are generally the staple foods eaten with other side dishes.

Congolese meals often consist of a starchy ingredient, along with vegetables and meat in the form of a stew. The starch can come in the form of a paste or mash made of cassava or corn flour, called fufu or ugali. When eaten, the fufu is rolled into golf ball-sized balls and dipped into the spicy stew—often an indentation is made with the thumb in order to bring up a thimbleful of sauce.

LEGAL FRAMEWORK GOVERNING INVESTMENT IN THE DRC

For more than a decade, DRC has engaged in a vast program of legislative and regulatory reforms related to investment with the aim of making its business environment competitive and attractive. These reforms aim to make the DRC one of the best business destinations in Africa.

The said reforms have enabled the DRC to acquire an important legal arsenal consisting of the following legislative and regulatory texts:



LEGAL FRAMEWORK GOVERNING INVESTMENT IN THE DRC CONT.

frameworks that promote the establishment and growth of subject to the ordinary law regime with the exception of the businesses and these include:

- Article 35 & 36 of the DRC Constitution guarantees the right Act No. 004/2002 on the Investment Code to private initiative to all nationals as well as foreigners. As per the constitution;
 - Private property is sacred and the State shall guarantee the right to individual or collective property acquired in accordance with law or custom
 - ii. The State also encourages and ensures that private, domestic and foreign investments are secured
 - iii. No one may be deprived of their property except in the interest of the public and in return of fair and prior compensation granted under the conditions set by law
 - iv. The State guarantees the right to private initiatives carried out by both nationals and foreigners
- The Public- Private Partnership Act provides for the guarantee of performance of partnership contracts signed with the Government regardless of any change in the regime (Art 15)

The DRC government has put in place legal and regulatory. The taxation of businesses under this type of arrangement is reduction of income tax on profits and profits, as set at 15%

- - Act No. 004/2002 on the Investment Code through the provisions of articles 23-30 provides from investment security mechanisms and guarantees as well as customs, tax and Para fiscal exemptions

It is important to read and understand the other legal texts indicated in DRC's Legal Arsenal on page 33 including Grant Customs Exemptions, Agriculture Act and the Value Chain Partnership Act among others to ensure that your business is operating within the confines of the Law.

OBTAINING A WORK PERMIT IN DRC

Procedure for obtaining a work card/work permit

To take up employment in the DRC, any foreigner must first obtain a work permit for himself. Additionally, any employer wishing to hire or retain a foreign worker under an employment contract must apply for and obtain a work for the benefit of that worker.

To obtain the work permit, the employer must submit a file to the National Commission for Foreign Employment (CNEE), containing the following documentation:

- Work permit request form
- Transmittal letter form
- Nominal roll for foreign personnel
- Draft employment contract
- Work Curriculum Vitae
- Documents establishing the worker's professional qualification (education credentials or any other supporting documents)
- Passport photo
- Detailed company organogram
- Professional development or adjustment training program
- Job description
- Proof of payment pf contributions due to CNSS and INPP
- Photocopies of all pages of the passport
