In consideration of the Bank allowing me the undersigned customer to open the account with Equity Bank Rwanda PLC ("the Bank"). I hereby agree that the signature signed by me in characters other than Roman or a thumbprint to the account opening form is complete and in order. I hereby authorise and indemnify the Bank as follows:

- 1. The Bank is authorised to accept and act upon any instructions, communications and documents (Bank or otherwise) signed by me in characters other than Roman or a thumbprint.*
- 2. I hereby irrevocably undertake to indemnify the Bank and hold it harmless from and against all cost (including without limitation legal fees and expenses, claims, losses, liabilities, damages and proceedings) whatsoever that the Bank may suffer or incur or that may arise as a result of the Bank's accepting or acting upon such instructions, communication or documents (Bank or otherwise). Furthermore, I hereby irrevocably release the Bank from all liability in the event that any Bank document signed by me in characters other than Roman or a thumbprint is altered, illegible, interrupted, duplicated, incomplete for any reason.*
- 3. In the event that I suffer any loss as a result of your honoring such instructions or Bank document, I shall have no claim or redress against you, whatsoever.*
- 4. I agree that you may at any time without notice to me, set off or transfer any sum or sums standing to the credit of any one or more of my accounts with you in or towards the satisfaction of my/our liabilities to you arising out of your honoring the instructions on my behalf.*
- 5. I agree that if I fail to pay on demand any sum payable hereunder, that interest shall accrue thereon from the date of such demand until full liquidation at your prime lending rate ruling at the time of call / demand.*
- 6. I agree that no delay or omission or granting of any indulgence on your part in exercising any right power, privilege or remedy in respect of this indemnity shall be construed as a waiver thereof, nor shall any single or partial exercise of any other right, power, privilege or remedy preclude any further exercise of any right, power, privilege or remedy. The right powers, privileges or remedies provided in this indemnity are cumulative and not exclusive of any rights, powers, privileges or remedies provided by law.*
- 7. It is not my intention that the instruction signed by me in characters other than Roman or a thumbprint referred to above should be confirmed in writing or by telephone and I hereby ratify and confirm all that you shall do on my/our behalf by virtue of such instructions provided only that you acted in good faith.*
- 8. The Bank shall have absolute discretion, for any reason whatsoever, to act or not to act upon instructions or Bank documentation signed by me in characters other than Roman and/or to request verification of documents and instructions signed by such means.*
- 9. That all authorisations, I have given and certified to the Bank as now governing the operation of my account(s) with the Bank are hereby confirmed to be in full force and effect, except as the same may be supplemental or modified by the foregoing part of this authorisation*
- 10. I hereby hold the Bank free from all loss and responsibility by reason of the mistranslation or misinterpretation of such letters or of delay in carrying out such instruction*
